研究課題

Title: Human Security and Poverty in Asia: an assessment from the poverty reduction cooperation from Bangladesh.

Brief Description: Poverty is a cause and a product of human insecurity. Eighty percent of the world's 20 poorest countries have suffered a major war in the past 15 years. The link between poverty and confrontation is not a question of income or material hardship alone: the poor are not inherently rebellious. But when deprivation is coupled with human rights violation, injustice and stark inequalities, history has shown that armed conflict, terrorism and other violence are not far behind. Thus overall human security is hampered. So, most of the development cooperation is targeted to reduce poverty to achieve the number one target of MDG and ultimately improve human security. Under this scenario this study will try to assess the basic link between poverty and human security and how international development co operations addressing this issue from human rights based approach? To prove theoretical links practically this study will assess some international poverty reduction co operations targeting improvement of human security in Bangladesh, one of the poorest countries of South Asia. So, basically this study will try to find out how poverty reduction development projects are implemented under human rights based approach with ultimate goal of improving human security.

The conference focused on cross-border human security issues in Asia, including those originating from and related to globalization. Various issues discussed in different panels include development, poverty, migration, violence, conflict, education, human rights, climate change, regional cooperation etc. from human security point of view. I have participated in different sessions especially in panels related to human security assessment from the view point of development, poverty, conflict, security and regional cooperation. And from various discussion and presentation tried to understand matters related to my research field.

In 4th October, 2007 I presented a paper titled `Human Security in Asia` by Universal Human Rights or Cultural Relativism?` under the panel `Human rights and Human Security`. My presentation explains how debate between Asian cultural relativism and Universal Declaration of Human Rights endangering human security in Asia by dividing Asian countries with in Asia and with rest of the world. I also tried to find out how Asian countries can promote their effort to have a regional human rights and human security platform like Europe by enhancing Asian Regional Integration and Regional Cooperation.
